- Individuals may call 800-427-7247 to book their hotel reservation and must mention the offer/group code "S04SO23" to receive the special Group rate. Any reservations made this route will be assessed a fee of \$10.00 plus current sales tax, per reservation.
- To avoid paying the above \$10.00 fee, individuals may book their hotel reservations using the following weblink.

- The booking weblink is defaulted to a one night stay, however the dates can be updated by following the below steps
  - a. Click either of the defaulted dates displayed which then brings up a calendar
  - b. In the calendar select the appropriate arrival date
  - c. Then choose the appropriate departure date
  - d. Finally click the **UPDATE** button
- Each individual attendee will be responsible for his/her own guestroom, tax, amenity fees and incidentals.
- All reservations must be guaranteed with a deposit for the first night's guestroom and tax charge which will be billed immediately to the cardholder's account.
- A daily resort/amenity fee of \$15.00 per room, per night plus the current occupancy tax will be charged. Unless otherwise specified, the resort/amenity fee will be posted to the individual's room and will be the individual's responsibility to pay, including any other incidentals (movies, food, beverage, early/late check in/out fees, etc.). The amenity fee includes:
  - a. Two (2) Guest admissions per day to the Fitness Center
  - b. Basic WIFI to include two (2) devices per room per day



#### PROPOSAL BYLAW CHANGE #1

#### **CURRENT SCR BYLAW**

ARTICLE V REGION CONFERENCE

**Section 2c: Registration Fee** 

c. A **refund** of Conference fees other than mandatory fees shall be made if requested by the Friday, one (1) week prior to the official meeting hour. **(Conference Action 2006)** 

#### **PROPOSED CHANGE**

**ARTICLE V REGION CONFERENCE** 

**Section 2c: Registration Fee Proposed language** 

c. A **refund** of Conference fees, other than mandatory fees, shall be made if requested by the Friday, one (1) week prior to the official meeting hour **if funds remain after all conference expenses are paid.** (Conference Action 2006, 2023)

#### **RATIONALE**

The Region should not incur a negative balance for a Region Conference due to refunds being issued for conference fees before all bills associated with the Conference have been paid. Refunds should only be paid when funds are available that will not result in a loss.

#### PROPOSAL BYLAW CHANGE #2

#### **CURRENT SCR BYLAW**

ARTICLE VI DISTRICT MEETINGS Section 4b: Registration Fee

b. A \$15.00 late registration fee shall be assessed for each member and/or visitor registration received after the cut-off date as published in the Call for District Meetings. The cut-off date shall be no more than *fourteen (14) days* prior to the official meeting date of the meeting. (Conference Action 2000)

#### **PROPOSED CHANGE**

**ARTICLE VI DISTRICT MEETINGS** 

**Section 4b: Registration Fee** 

b. A \$20.00 late registration fee shall be assessed for each member and/or visitor registration received after the cut-off date as published in the Call for District Meetings. The cut-off date shall be no more than *fourteen (14) days* prior to the official meeting date of the meeting. (Conference Action 2000, 2023)

#### **RATIONALE**

Uniform late registration fee for District Meetings and Region Conference.

#### PROPOSAL BYLAW CHANGE #3

#### **CURRENT SCR BYLAW**

**ARTICLE VI DISTRICT MEETINGS Section 4c: Registration Fee** 

c. A **refund** of meeting fees, other than mandatory fees, shall be made if requested by the Friday, one (1) week prior to the official meeting hour. **(Conference Action 2006)** 

#### **PROPOSED CHANGE**

**ARTICLE VI DISTRICT MEETINGS Section 4c: Registration Fee** 

c. A **refund** of Meeting fees, other than mandatory fees, shall be made if requested by the Friday, one (1) week prior to the official meeting hour **if funds remain after all meeting expenses are paid.** (Conference Action 2006, 2023)

#### **RATIONALE**

The Region should not incur a negative balance for District Meetings due to refunds being issued for meeting fees before all bills associated with the meeting have been paid. Refunds should only be paid when funds are available that will not result in a loss.

#### PROPOSAL BYLAW CHANGE #4

#### **CURRENT SCR BYLAW**

ARTICLE VII NOMINATING COMMITTEE & ELECTION PROCESS Section 2a: Candidates for Office

a. On or before *October 15* of the odd-numbered year, the Chairperson of the Nominating Committee shall invite clubs in the Region to suggest members for consideration by the Nominating Committee. Clubs shall reply by *December 15*. The Chairperson shall ascertain from their respective Club Presidents that persons suggested for nominations are members in good standing and from the Region Treasurer that all such clubs are in good standing and not in jeopardy. The Chairperson shall contact persons in good standing whose names were submitted to ascertain their willingness to serve in office if nominated and elected. All members replying affirmatively shall submit to the Chairperson a resume of their qualifications. The committee may contact other Soroptimists as to their willingness to serve and obtain a resume from them.

#### **PROPOSED CHANGE**

ARTICLE VII NOMINATING COMMITTEE & ELECTION PROCESS

Section 2a: Candidates for Office

a. On or before *October 15* of the odd-numbered year, the Chairperson of the Nominating Committee shall invite clubs in the Region to suggest members for consideration by the Nominating Committee. Clubs shall reply by *December 15*. If there is still no candidate for an open position, then the Chairperson will email clubs again and extend the deadline to January 15<sup>th</sup>. The Chairperson shall ascertain from their respective Club Presidents that persons suggested for nominations are members in good standing and from the Region Treasurer that all such clubs are in good standing and not in jeopardy.

The Chairperson shall contact persons in good standing whose names were submitted to ascertain their willingness to serve in office if nominated and elected. All members replying affirmatively shall submit to the Chairperson a resume of their qualifications. The committee may contact other Soroptimists as to their willingness to serve and obtain a resume from them.

#### **RATIONALE**

To allow for sufficient time to notify the clubs by email and obtain a candidate for office should the initial time period expire with no valid candidate having been brought forth.

#### PROPOSAL BYLAW CHANGE #5

#### **CURRENT SCR BYLAW**

#### ARTICLE VII NOMINATING COMMITTEE & ELECTION PROCESS

**Section 3: Election Process** 

- a. The Nominating Committee shall read its nominations at the Conference at least **two (2) hours** before the time set for opening the polls. Nominations may be made from the floor no later than **one (1) hour** before the time set for opening the polls. The person or club making the nomination from the floor shall be responsible for obtaining the consent of the nominee and for providing for distribution a statement of the qualification of the candidate in the same format as those presented by the Nominating Committee (as used in the Call to Conference).
- b. The official program shall indicate the day and hour of nominations and of balloting.

#### PROPOSED CHANGE

#### **ARTICLE VII NOMINATING COMMITTEE & ELECTION PROCESS**

**Section 3: Election Process** 

- a. The Nominating Committee shall read its nominations at the Conference at least **two (2) hours** before the time set for **the election**. Nominations may be made from the floor **only for an office with no candidate(s) presented by the Nominating Committee** no later than **one (1) hour** before the time set for **the election**. The person or club making the nomination from the floor, **only for an open position with no candidate(s)**, shall be responsible for obtaining the consent of the nominee and for providing for distribution a statement of the qualification of the candidate in the same format as those presented by the Nominating Committee as used in the Call to Conference.
- b. The official program shall indicate the day and hour of nominations and of balloting.

#### **RATIONALE**

The South Central Region utilizes an open nomination process that lasts two to three months. There is no legitimate reason for someone wishing to run for office to wait until the last minute to submit her name and credentials. Also, the current process allows for someone to attempt to throw an election by utilizing nominations from the floor.

#### PROPOSAL BYLAW CHANGE #6

#### **CURRENT SCR BYLAW**

#### **ARTICLE VIII COMMITTEES**

**Section 3: Remembrance** 

The Remembrance Committee shall honor members who have died since the previous Region Conference and shall preside over a service of recognition at each Conference. In addition, an annual gift of \$250 shall be sent to Soroptimist International of the Americas in memory of those members. (Conference Action 2019)

#### PROPOSED CHANGE

#### **ARTICLE VIII COMMITTEES**

**Section 3: Remembrance** 

The Remembrance Committee shall honor members who have died since the previous Region Conference and shall preside over a service of recognition at each Conference.

#### **RATIONALE**

South Central Region monies and budget are very tight. This change will allow South Central Region to keep that money in our Region for its needs.

#### PROPOSAL BYLAW CHANGE #7

#### **CURRENT SCR BYLAW**

#### **ARTICLE VIII COMMITTEES**

**Section 4: District Meetings Planning Committee** 

The District Meetings Planning Committee chairperson shall recruit one committee member from each District. Ex-officio members shall include the Governor, the Governor-Elect, and the three District Directors. (Conference Action 2019)

#### **PROPOSED CHANGE**

#### **ARTICLE VIII COMMITTEES**

**Section 4: District Meetings Planning Committee** 

The District Meetings Planning Committee Chair, along with ex-officio members including the Governor, Governor-Elect, and the three District Directors, shall recruit *two* committee members from each District.

#### **RATIONALE**

The committee took the place of the host club from when three individual District Meetings were held. Three people cannot replace an entire club, especially when having to work remotely to keep the location centralized (as best as it can be).

#### PROPOSAL BYLAW CHANGE #8

#### **CURRENT SCR BYLAW**

#### **ARTICLE IX REGION EXPENSES**

**Section 6: Chartering New Clubs** 

- c. Expenditures incurred by the sponsoring club shall not exceed \$500.00. If it appears expenditures will exceed \$500.00, the excess may be approved by the Region Board provided the additional expense is warranted and funds are available.
- d. All authorized expenses, when accompanied by receipts, will be reimbursed by the Region and charged to Membership Account.

#### **PROPOSED CHANGE**

#### **ARTICLE IX REGION EXPENSES**

**Section 6: Chartering New Clubs** 

- c. Authorized expenditures incurred by the Charter Team shall not exceed \$500.00. If it appears expenditures will exceed \$500.00, the excess may be approved by the Region Board provided the additional expense is warranted and funds are available.
- d. Authorized expenses, when accompanied by receipts, will be reimbursed by the Region and charged to **Club Charter** Account.

#### **RATIONALE**

Charter Team is the current language used by SIA. Also, to put checks and balances in place to ensure that only authorized expenses related to chartering a new club are paid, and that those expenses are reflected correctly within the Region books. New clubs are being chartered by a group of members from several clubs, rather than an individual club.

#### PROPOSAL BYLAW CHANGE #9

#### **CURRENT SCR BYLAW**

#### **ARTICLE X REGION DUES**

**Section 1: Region Dues** 

- a. Each club shall pay to the Region annual dues of \$20.00 for each member, except Friendship Links. The dues are payable on or by July 1 on the membership as of that date.
- b. New member dues are on a graduated scale as follows:

July 1 through December 31 \$20.00
 January 1 through March 31 \$18.00
 April 1 through June 30 \$15.00

(Conference Action 2014/Region Dues increase effective July 1, 2016)

#### **PROPOSED CHANGE**

#### **ARTICLE X REGION DUES**

**Section 1: Region Dues** 

a. Each club shall pay to the Region annual dues of \$30.00 in 2023, \$40 in 2024, and \$50 in 2025 and thereafter, for each member, except Friendship Links. The dues are payable on or by July 1 on the membership as of that date.

b. New member dues are on a graduated scale as follows:

July 1 through December 31
 January 1 through March 31
 April 1 through June 30
 January 1 through June 30

(Conference Action 2023/Region Dues increase effective July 1, 2023)

#### **RATIONALE**

Region dues have remained constant for over ten (10) years. Current inflation values read from 8% to 18%. The cost of everything has gone up, especially since the pandemic. It is not wise to continue dipping into reserve accounts to make the budget which is stretched thin.

The cost of doing business, obtaining relevant speakers and workshop presenters, and venues for gatherings continues to increase. To provide the types and quality of events that members can benefit from, increased revenue is required. Since 1995 the Region size has been cut in half (64 clubs in 1995 to 31 clubs in 2022). We are trying to put on quality events with less than half the clubs, and half the income that the Region had in 1995. Other organizations and training programs typically charge upwards of \$250 for a one-day event. Our members are currently paying an average of \$150 for the whole weekend including food.

#### ARTICLE XII SOLICITATION OF FUNDS

**Section 1: Solicitation of Funds** 

- a. Funds shall not be solicited by this Region from members of clubs except when action authorizing such solicitation has been specifically approved by the Region Conference after notice to the clubs through the Call to Conference. If the Region Conference will not be held within three (3) months, approval may be given by the Region Board with a two-thirds vote at a meeting or a three-fourths vote by mail or email ballot.
- b. If a club wishes to invite members of any other club to participate in a Ways and Means Project, it should send the information to the President of the other club, who, together with her board, shall decide whether the members of the club are to be approached. The originating club may not circularize the members of any other club without this clearance.

#### **PROPOSED CHANGE**

#### ARTICLE XII SOLICITATION OF FUNDS

**Section 1: Solicitation of Funds** 

a. If a club wishes to invite members of any other club to participate in a Ways and Means Project, it should send the information to the President of the other club, who, together with her board, shall decide whether the members of the club are to be approached. The originating club may not circularize the members of any other club without this clearance.

#### **RATIONALE**

Currently, fundraising at the Region Conference is limited to the silent auction for Lucy Keller Dreams in Action and for Soroptimist International of the Americas (SIA) Live Your Dream program. There is no desire to take away from either of these activities. However, South Central Region needs to actively engage in fundraising. Such fundraising activity would be limited to Region Conference or District Meetings. There will be no campaigns to solicit donations from members of the South Central Region similar to those conducted by SIA of the membership. While there are plans to have the ability to donate through the Region website, that is a voluntary action on the part of an individual.
